This annual event, hosted by Legal Services of Northern Virginia (LSNV) and the Alexandria Bar Foundation and supported by the Fairfax Law Foundation and the Arlington County Bar Foundation, featured Virginia Supreme Court Justice William C. Mims who spoke passionately about the role of mercy within justice; how they have long been interwoven. JUDICIAL ENDORSEMENT

In May, the Honorable Uley Norris Damiani, of the Juvenile and Domestic Relations District Court of the Eighteenth Judicial District, for the City of Alexandria, announced that she was stepping down from her position effective August 15, 2019. The Alexandria Bar Association deeply appreciates her dedication and years of service.

Almost immediately after Judge Damiani's announcement, the Association began the process of evaluating candidates who sought to fill the seat on the local bench she was vacating.

The timetable for evaluating candidates was compressed to prevent, if possible, a vacancy on the important J&DR bench. The task was to identify and endorse, if possible, a candidate in time to allow our local representatives to make a nomination and have the General Assembly elect a new judge by early summer. Although that did not happen, it was not for want of effort.

Following the Association's established procedures, the President, Chris Wright, and Board of Directors promptly announced the upcoming vacancy, appointed a Committee of volunteer members to interview and evaluate candidates, and gave notice of when candidates should submit their applications. The Committee had a small cadre of experienced members, but many new ones, too. All pitched in willingly and tirelessly to review the applications, conduct the interviews, and undertake the evaluations. In that process, the Committee received guidance from the President and the Board, and support from the Association's Executive Director, Jill Calabria.

Impressively, eight qualified and public-spirited candidates submitted their applications. Each candidate completed a detailed questionnaire, submitted a significant writing sample, and a current resume, and then sat for an in-depth interview. We are fortunate to have so many capable lawyers who are willing to serve as our judicial officers.

After the interviews, the Committee deliberated and then submitted its evaluations to the President

and the Board for their approval. Upon approval, the evaluations were published in advance of the Association's endorsement vote. The turn-out for the endorsement vote was strong, with 195 votes cast out of the total of 299 members who were eligible to vote. This strong turn-out reflected the importance of this judicial position and the esteem the voters had for these candidates.

As a result of the vote, Rebecca Wade earned the Association's endorsement. The Association congratulates her and wishes her well in the upcoming nomination and judicial election process. Although the General Assembly did not take action to fill this seat when it met for a special session in July, we expect that filling this seat will be a priority when the General Assembly is next in session.

JUDGE DAMINI FAREWELL

Judge Uley Damiani was appointed by the Alexandria Circuit Court as an interim Juvenile and Domestic Relations judge in July 2008 and subsequently confirmed by the General Assembly in January 2009. During her years on the JDR bench she also had the privilege of working on various Supreme Court committees including long-term efforts on both the Committee on District Courts and the Judicial Ethics Advisory Committee. In 2015 she was a gubernatorial appointee to a three-year term on the statewide Advisory Committee on Juvenile Justice & Prevention (ACJJP). Proud as she was to serve the Commonwealth in those capacities, she says her heart was always with serving the City of Alexandria. Judge Damiani enjoyed collaborating with all court-related agencies and practitioners to ensure fairness and best practices for the community in the courtroom. She intends to continue that collaboration by remaining an active member of Alexandria's team to reduce racial and ethnic disparity in the juvenile justice system (RED). What she will miss the most, however, will be engaging and interacting with the kids who come through the court system on so many different types of cases and with innumerable different needs. She says that trying to connect with them and help them, and then, especially, seeing them succeed gave her the greatest satisfaction as a judge.



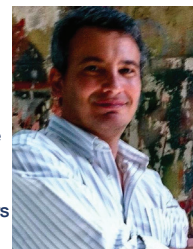
JOE KING

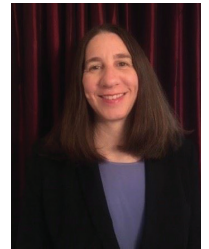
