### **PRESIDENT'S LETTER**

#### **Dear Colleagues,**

I hope you are having a summer of "well-being." The Board is already working very hard to make the upcoming year a success for all of you. Leonard Heath Jr, the new VSB President, hopes to be in attendance. The CLE Marathon planning is underway, and more information will be forthcoming. Lawyer wellness is top of mind this year for Virginia lawyers. I encourage everyone to find their June copy of the Virginia Lawyer and read Leonard Heath's article "End Zones, Ethics, and Epiphanies." In his article, Leonard discusses a report on lawyer wellness published by the National Task Force on Well-Being called: The Path to Lawyer Well-Being: Practical Recommendations for Positive Change (Task Force Report or Report). The Task Force Report can be found online at lawyerwellbeing.net.

I encourage everyone to read the Task Force Report because its influence is already being felt across our profession. Chief Justice Lemons, a member of the Task Force that authored the Report, formed a committee on lawyer well-being chaired by Justice William C. Mims. Even the MCLE Board of the Virginia State Bar is getting in on the action. The MCLE Board is currently considering amendments to Opinion 19 that would allow lawyer well-being topics to be considered for CLE credit. As Leonard points out in his article:

...while the report addresses impaired lawyers, the report is more than a report on 'impaired lawyers.' Wellness issues arise long before lawyers become impaired. And, most lawyers who suffer from wellness issues, may never get to the point of actually being clinically impaired. However, even wellness problems that fall short of clinical impairment can affect our clients, our families, and the profession.

In our corner of Virginia, the question is: what can we do? Fortunately, the report provides answers for several different stakeholders: judges, bar associations, regulators, and legal employers. The recommendation for bar associations is to (i) encourage and provide education on well-being topics, (ii) form a lawyer well-being committee, and (iii) "support members' wellbeing and role model best practices in connection with their own activities and meetings."

Over the next year, and hopefully beyond that, our bar association will focus on lawyer well-being issues. I welcome your encouragement, ideas, and help. "Progress not perfection – all we can do is try."
